legal obligation joint liability is an obligation for which more than one person is responsible joint and several liability refers to the status of those who are responsible together as one unit as well as individually for their conduct'

'theories of liability motor carrier claims fg

June 2nd, 2020 - traditionally the broker has avoided liability for any injuries caused by the driver transporting the load by demonstrating that the motor carrier was an independent contractor because the broker is not the employer of the driver it cannot be held liable under a theory of agency or vicarious liability'

'site safety managing the risk of legal or contractual

June 2nd, 2020 - once the project owner has executed a contract with its independent contractor delegating site safety responsibility to that firm the owner generally has no legal liability for injuries to the employees of the independent contractors unless the owner asserts some control over the means methods and procedures of the contractor s work or takes some action at the project that causes or contributes to an injury'

May 21st, 2020 - if an employee is convicted under section 7 of the health and safety at work act 1974 for failing to take reasonable care in their work to ensure the health and safety of themselves or others this offence has been used by the health and safety
